**RESOLUTION No. 20 - 017 -CC**

**WHEREAS**, the Board of County Commissioners desires to conduct a public hearing on its intention to adjust rates at Grant County operated disposal facilities to meet both current and future needs; and

**WHEREAS**, Resolution No. 20-077-CC set the public hearing date of September 22, 2020 and now needs to be rescinded and the hearing date must be rescheduled; and

**WHEREAS**, it is the intention of Grant County Public Works to adjust the rates at Grant County operated disposal facilities on January 1, 2021; and

**WHEREAS**, Resolution No. 18-123-CC adopted December 18, 2018 was the previous adoption of the Fee Schedule and has been deemed inadequate to fund the administrative, maintenance, and operational costs; and

**WHEREAS**, the following fee schedules showing the increased fees will be considered: see ATTACHMENTS A & B.

**NOW, THEREFORE, BE IT RESOLVED**, that a public hearing be held at 1:30 P.M. on September 29, 2020.
